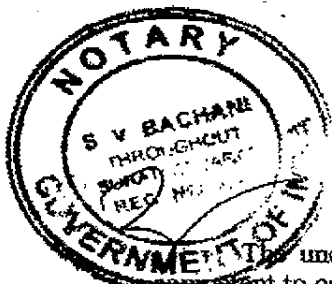

1. **ARTICLE I Name**

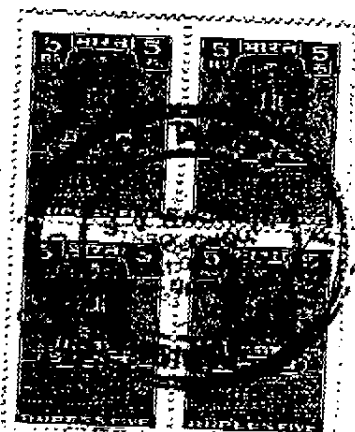

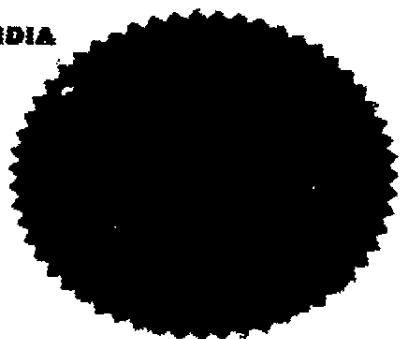
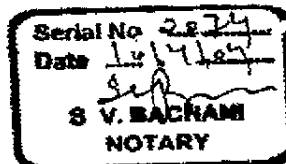
