## ARTICLES OF INCORPORATION OF MIDCOAST FINANCIAL, INC.



In compliance with Chapter 607 of the Florida Business Corporation Act, the undersigned, a natural person (the "Incorporator"), for the purpose of organizing a corporation under the provisions and subject to the requirements of the laws of the State of Florida hereby certifies that:

Ĭ.

The name of the corporation shall be MidCoast Financial, Inc.

II.

The street address and mailing address of the initial principal office of the corporation is 1926 10th Avenue North, Suite 400, Lake Worth, Florida 33461.

This corporation is authorized to issue only one class of stock, to be designated Common Stock. The total number of shares of Common Stock presently authorized is One Hundred (100), each having a par value of one dollar (\$1.00).
