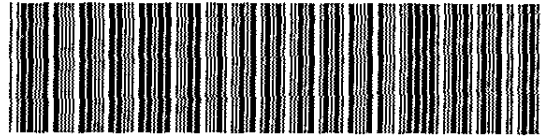

ARTICLES OF INCORPORATION OF ARCHITEKTUR, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be Architektur, Inc.

ARTICLE II. PRINCIPAL OFFICE

The address of the corporation's principal office is 400 South Washington Blvd, City of Sarasota, County of Sarasota, State of Florida 34236.

ARTICLE III. PURPOSE
