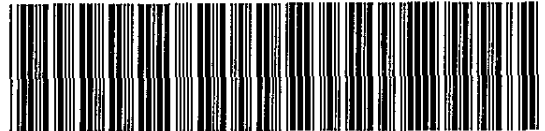

ARTICLE I - NAME
