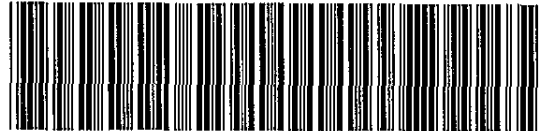

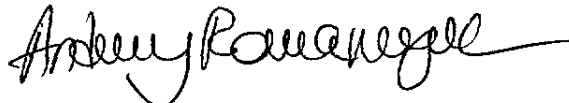

CORPORATE NAME
