To Whom It May Concern:

Per our phone conversation last week, I am sending this letter with detailed information, just as you requested from me.

As I explained over the phone, my corporation Bouncing 4 Joy, Inc. was deactivated due to an error. I had sent the annual payment of \$150.00 to your office for the year of 2005. A few days ago, I went to my accountant to do my taxes for the year of 2005 and as she checked in the computer, she tells me that my corporation does not show as active and that it could be due to lack of paying my taxes or renewal fee. After this, I went home and looked for the certified receipt from the United States Post Office which showed when and where it was sent and proceeded to call you to inquire about the reason for deactivating the company, I spoke to a lady by the name of Karen I believe, and after her checking in the system, it showed that the payment had been received. Apparently, at that point, they realized that my payment is missing the FEI number and proceeded to send me a request for such number. I received the request and i sent it back with the requested information. Due to an error from my part, instead of sending this back to the right address, it was sent to the Department of the Treasury (please see enclosed copy of U.S Post Office certified receipt). After explaining the above to Karen, she explained to me that I needed to send this letter with a full explanation of the events. She stated that unless I followed these instructions, you would not consider waiving the \$600.00 fine that you would otherwise penalize me with, under normal circumstances. I am enclosing a \$150.00 payment for the 2006 renewal fee.

I apologize about this, and would greatly appreciate it if you could please waive the \$600.00 fine that I would have to pay, due to my error. My corporation is fairly new, does not have much capital because it is a very small one. After our area was affected by hurricane Wilma, it has barely generated any revenue. I have not only lost part of my house and my working car, but now am facing a fine that would otherwise help me pay for that car that is still in the shop trying to get it repaired.
