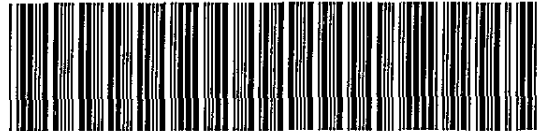

**ARTICLE I – NAME**

The name of this corporation is **JL GROUP SERVICES, INC.**

**ARTICLE II – PRINCIPAL PLACE OF BUSINESS AND ADDRESS**

**ARTICLE III – DURATION**

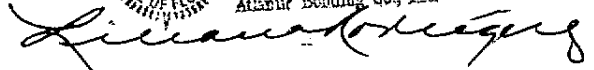
