**ARTICLE I
NAME**

The name of this corporation is P.H.B. ELECTRIC, INC.

**ARTICLE II
DURATION**


ARTICLE IX

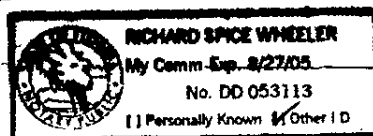


