**ARTICLE I - NAME AND ADDRESS**

The name of this corporation is IVAX Treasurechest Holding Company. The address of the principal office and the mailing address of this corporation is 4400 Biscayne Boulevard, Miami, Florida 33137.

**ARTICLE II - PURPOSE**
