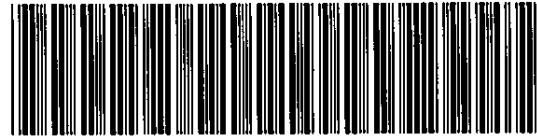

- A. The name of the corporation is Linear RX, Inc. (the "Corporation").
- B. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on April 29, 2004.
- C. An amendment to the Articles of Incorporation was adopted as of October 8, 2008, by the sole shareholder and the sole member of the Board of Directors of the Corporation to amend "ARTICLE I - NAME" of the Articles of Incorporation in its entirety to read as follows:

"ARTICLE I-NAME"
