A. The name of the corporation is Linear Medical Solutions, Inc. (the "Corporation").

B. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on April 29, 2004.

C. An amendment to the Articles of Incorporation was adopted on November 16th, 2010, by the sole shareholder and the sole director of the Corporation to amend "ARTICLE I - NAME" of the Articles of Incorporation in its entirety to read as follows:

The name of the corporation shall be LMS Healthcare, Inc."

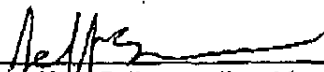
There are no other amendments to the Articles of Incorporation, except as stated above.
