



ARTICLE III - THE PURPOSE FORWHICH THE CORPORATION IS ORGANIZED IS:

- 3. TO ACQUIRE ANY PART OF BUSINESS INCLDUING GOODWILL OF ANY PERSON, FIRM, ASSOCIATION OR CORPORATION, WHETHER OR NOT THE BGUSINESS IS SIMILAR TO THAT WHICH THE CORPORATION IS ENGAGED;**
