## ARTICLE L NAME

The name of this corporation shall be SHINE TIME WINDOW CLEANING, INC.

# ARTICLE IL COMMENCEMENT & DURATION

This corporation is being organized for the purpose of providing general cleaning services under the laws of Florida and the United States of America.

#### ARTICLE III. CAPITAL STOCK

This corporation shall have the authority to issue 100 per value shares of common capital stock.
