

## ARTICLES OF INCORPORATION OF DICAST DESIGN, CORP.

The undersigned incorporator (s) hereby forms the following corporation Under the laws of the State of Florida:

#### ARTICLE I NAME:

DICAST DESIGN, CORP.

#### ARTICLE II

#### **PURPOSE:**

The corporation is organized to engage in any and all business permitted under the laws of the State of Florida.

#### ARTICLE III CAPITAL STOCK:

The maximum number of shares of stocks which this corporation is authorized to issue is 1000 shares of \$ 1.00 par value, common stock. Said shares of stock may be issued only for a consideration having a fair value as may be determined by the board of directors.

#### ARTICLE IV TERM OF EXISTENCE:

This corporation is to exist perpetually from the date these Articles are filed with the Department of State, subject to the laws of the State of Florida.
