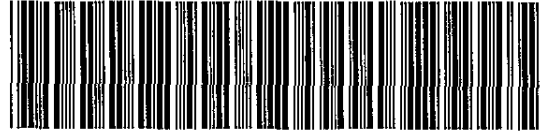

The undersigned, acting as incorporator of a Corporation under Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation of such Corporation.

ARTICLE I

The name of the Corporation shall be:

ARTICLE V

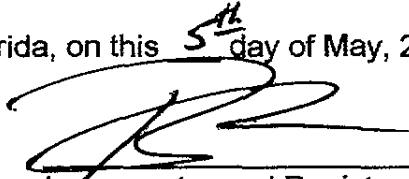
