ARTICLES OF INCORPORATION

OF

ALL POINTS BREVARD COUNTY, INC.

ARTICLE I - NAME

The name of this corporation is ALL POINTS BREVARD COUNT

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.
