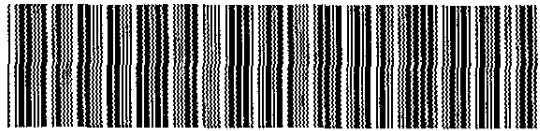

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607 Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is SAND KEY AIRCRAFT & WATER SPORTS, INC.
The principal place of business of the corporation is 255 Dolphin Point Road, #504, Clearwater Beach, Florida 33767.

ARTICLE II - DURATION

The duration of the corporation is perpetual.




