The general nature of the business to be transacted by this corporation shall be as follows:

A. Interpretations and translations

B. To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, of any other lawful purposes; to issue bonds, promissory notes, bills or exchange, debentures and other obligations and evidences of indebtedness, payable at a specified time or times secured by mortgage or otherwise.

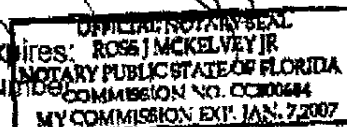
