ARTICLES OF INCORPORATION

OF

ADR USA ONLINE CORP.

THE UNDERSIGNED do hereby associate themselves for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be:

ADR USA ONLINE CORP.

ARTICLE II - PURPOSE

A.- To carry on and engage in the business of developing, manufacturing, distributing, exporting, marketing and selling all type of products, domestically and abroad.

B.- To carry on and engage Consulting, Advertising, Publishing and Internet Services domestically and abroad in any business activity, To supply of software and advising in computer science matter, the electronic data processing, the services of data transmission and the advising for the installation of electronic processors. Moreover it will be able to exercise the activity of administrative, managerial, technical advising and financial institution, and also market studies and opinion surveys. It will be able to carry out studies of advertising promotion, public relations, services of search and selection of the staff and to organize conventions.

C.- This company may buy shares of stock of any foreign and/or national companies throughout the world, and all types of investments in any business activity.

F.- To carry on and engage in any business or activity which may be authorized and permitted by virtue of laws of the United States of America and the State of Florida.

ARTICLE III - CAPITAL STOCK

The Corporation shall be authorized to issue capital stock in the following manner, to wit: 10,000,000.- (TEN MILLION) shares of common stock, having no par value.

ARTICLE IV - POWERS

The powers of the Corporation shall include all those conferred by the bylaws of the Corporation and the laws of the State of Florida.
