

# ARTICLES OF INCORPORATION ED

The undersigned incorporator, being a natural person competent Rolcontract for the purpose of forming a Professional Association Corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation in order to form a Professional Association Corporation under the laws of the State of Florida.

#### ARTICLE I

The Professional Association Corporate name is:

#### ARTICLE II

#### ARTICLE III
