**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF AXION MEDICAL, INC.**

AXION MEDICAL, INC., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article 1, in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE 1
NAME**

The name of the corporation shall be Sabine Neurotechnology, Inc.

2. The Articles of Incorporation of the Corporation are further amended by deleting the present form of Article 3 in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE 3
STOCK**

The aggregate number of shares of stock authorized to be issued by this corporation shall be 2,000,000 shares of common stock, no par value. Each share of issued and outstanding common stock shall entitle the holder thereof to fully participate in all shareholder meetings, to cast one vote on each matter with respect to which shareholders have the right to vote, and to share ratably in all dividends and other distributions declared and paid with respect to the common stock, as well as in the net assets of the corporation upon liquidation or dissolution.

3. The foregoing amendments shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.
