ARTICLE I
NAME

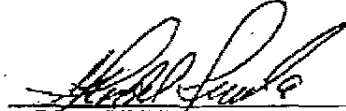

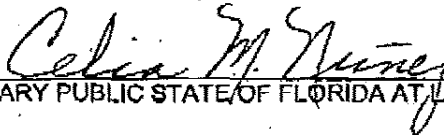
