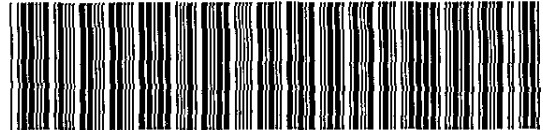

ARTICLES OF INCORPORATION

OF

SANDCASTLE SONOGRAPHY, INC.

ARTICLE I





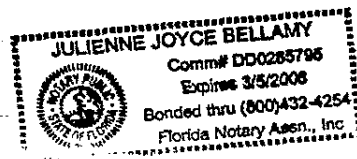
