

ARTICLES OF INCORPORATION

OF

Jacksonville Java, Inc.

The undersigned subscriber to these Articles of Incorporation. being a natural person competent to contract, hereby as Incorporator forms a business corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is Jacksonville Java, Inc.

ARTICLE II. CORPORATE ADDRESSES

The principal office and mailing address of the corporation is 2169 Hawkcrest Drive East, Jacksonville, Florida 32259.

ARTICLE III. GENERAL PURPOSE

The general purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE IV. CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is One Thousand Shares (1000), of a par value of One Cent (\$.01) per share, all of which shares shall be designated common shares. All common shares shall be identical

with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
