The Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which shall be designated "common shares".

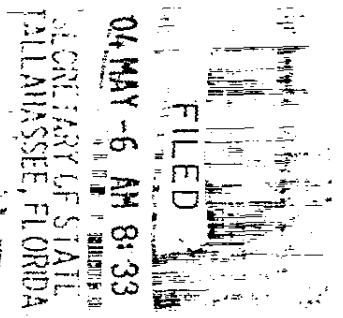




