

ARTICLES OF INCORPORATION OF BEECHER BODY SHOP, INC.

The undersigned hereby makes, subscribes, acknowledges, and files this certificate for the purpose of becoming a corporation for profit under the laws of the State of Florida:

ARTICLE I Name

The name of this Corporation shall be BEECHER BODY SHOP, INC

ARTICLE II Purpose

This Corporation shall be organized for the purpose of engaging in any business which is lawful under the laws of the State of Florida.

ARTICLE III Agent

The registered agent of this Corporation shall be Johnny Beecher. The address of the registered agent shall be 906 Blountstown Highway, Tallahassee, Florida 32304.

ARTICLE IV Existence

This Corporation shall have perpetual existence.

ARTICLE V Address

The initial street address of the principal office of this Corporation shall be 906 Blountstown Highway, Tallahassee, Florida 32304.

ARTICLE VI Capital Stock

The authorized capital stock of this Corporation shall consist of 1,000,000 shares of voting common stock having a par value of one cent (\$0.01) each.

ARTICLE VII Preemptive Rights, Cumulative Voting

Holders of the capital stock of the Corporation shall have the preemptive right to purchase new shares of stock or securities, or rights to acquire stock or securities of the Corporation. Cumulative voting shall not be allowed in the election of its directors or for any other purposes.

ARTICLE VIII <u>Directors</u>

This Corporation shall have no less than one (1) director nor more than seven (7). The Board of Directors of the Corporation shall consist of all of the stockholders (or, if any stockholder is a corporation or other entity, such shareholder's duly authorized representative). The initial director of the Corporation shall be as follows:

ARTICLE IX Incorporator

ARTICLE X Officers

The officers of the Corporation shall be a president, vice president and a treasurer, and such other officers or agents as may be appointed by the Board of Directors. All officers, agents or employees as may be necessary shall be chosen in such a manner, for such time, and have such duties as may be described by the By-Laws or determined by the Board of Directors. ARTICLE XI Indemnification
