Articles of Incorporation MASTERS LANDSCAPE OF FLORIDA INC.

1. Corporate Name

The name of the Corporation shall be: MASTERS LANDSCAPE OF FLORIDA INC. The principal place of business of this corporation shall be 208 S. ELLIOTT AVENUE, SANFORD, FL. 32771.

6. Existence.

This corporation shall have one director initially. The number of directors may be increased or diminshed from time to time by By-Laws adopted by the stockholders, but shall never be less than one.

8. Initial Directors:
