ARTICLE I - NAME

The name of this corporation is CREST BUILDERS, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on April 28, 2004.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of construction management as allowed under the laws of Florida.
