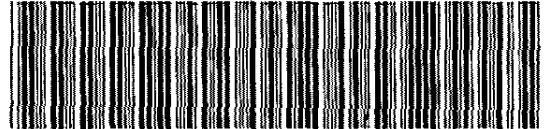

ARTICLE I - NAME AND PRINCIPAL LOCATION

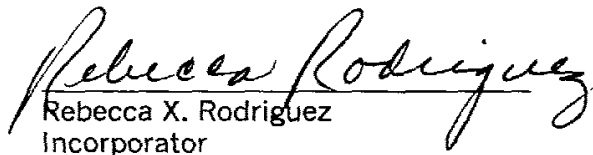

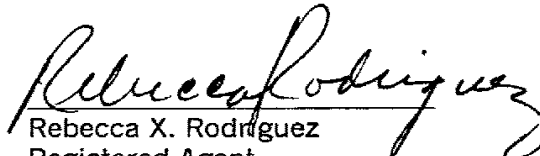
