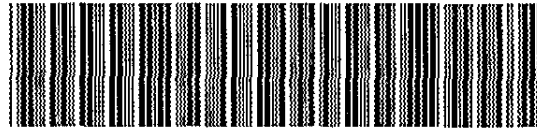

ARTICLES OF INCORPORATION OF ***JAX Resources, Inc.***

ARTICLE I. NAME
