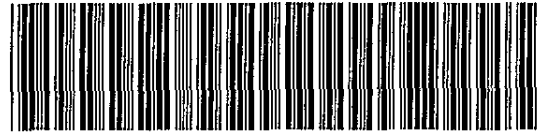

AQUATIC DESIGNS CONSTRUCTION, INC.


1. The name of the corporation is AQUATIC DESIGNS CONSTRUCTION, INC. (the "Corporation"). The document number of the corporation is P04000075245.
