
ARTICLE THIRTEEN

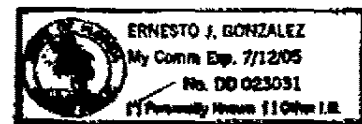
