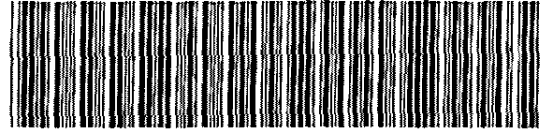

ARTICLES OF INCORPORATION  
OF

ASAD SOFTWARE

ARTICLE 1 - NAME

The name of the corporation (hereinafter called the corporation) is **ASAD SOFTWARE, INC.**

ARTICLE 2 - PRINCIPAL OFFICE

The principal place of business/mailling address is:

ARTICLE 3 - PURPOSE

The purpose for which the corporation is organized are: 1) to provide consulting services to civil engineering software designers and 2) to engage in any lawful activity for which corporations may be formed under Florida corporation laws.

ARTICLE 4 - SHARES

The total number of shares of capitol stock which the corporation has authority to issue is 2000 divided into 1000 shares of Class A common stock with \$0.01 par value and 1000 shares of Class B common stock with \$0.01 par value. The following is a description of each class of stock of the corporation with the preferences, conversion, and other rights, restrictions, voting powers, and qualifications of each class:

1. Except as hereinafter provided with respect to voting powers, the Class A common stock and the Class B common stock of the corporation shall be identical in all respects.
2. With respect to voting powers, except as otherwise required by the laws of the State of Florida, the holders of Class A common stock shall possess all voting for all purposes including the election of directors, and holders of Class B common stock shall have no voting power whatsoever, and no holder of Class B common stock shall vote on or otherwise participate in any proceedings in which actions shall be taken by the corporation or the stockholders thereof or be entitled to notification as to any meeting of the Board of Directors or the stockholders.

ARTICLE 5 - BOARD OF DIRECTORS

The number of directors constituting the initial Board of Directors of the corporation is one (1), this being **TIMOTHY A. HITESHEW**.


ARTICLE 6 - REGISTERED AGENT

The post office address of the initial registered office of the corporation in the State of Florida is **32807 WOLF'S TRAIL, SORRENTO, FL 32776**. The name of the county is **LAKE**. The name of the initial registered agent of the corporation is **TIMOTHY A. HITESHEW**.
