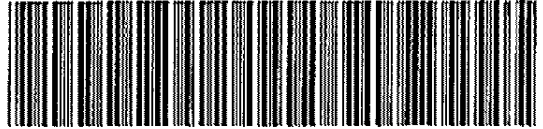

ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be:

CASTLE KEEPERS REALTY, INC.

ARTICLE II - TERM OF EXISTENCE

The existence of the corporation shall be perpetual and shall begin on the date of filing of these Articles of Incorporation.

ARTICLE III - PURPOSE


