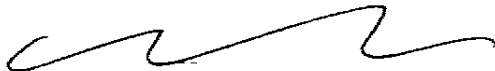

ARTICLES OF INCORPORATION
OF
KIRKPATRICK APPRAISAL SERVICE, P.A.

The undersigned subscribers to these Articles of Incorporation, being natural persons, competent to contract, do hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I.
Name

The name of this corporation is: **KIRKPATRICK APPRAISAL SERVICE, P.A.**

ARTICLE II.
Nature of Business

The general nature of the business or businesses to be transacted by this corporation is the appraisal of real property and related services.

ARTICLE III.
Term of Existence

The term of existence of the corporation shall be perpetual.

ARTICLE IV.
Capital Stock

The maximum number of shares that this corporation is authorized to have outstanding at any one time is **ONE THOUSAND (1,000) SHARES** having a nominal or par value of \$1.00 per share. In order to hold or own stock within this corporation, each person must be licensed as a registered property appraiser with the Department of Business and Professional Regulation of the State of Florida.

A majority of the outstanding shares of the corporation entitled to vote, present in person or by proxy, shall constitute a quorum at any meeting of the stockholders for the management of the business of the corporation.

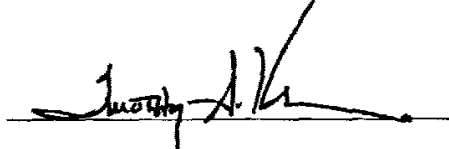

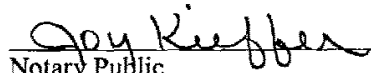
