

ARTICLE I

Name

The name of the Corporation shall be MUNNY, INC.



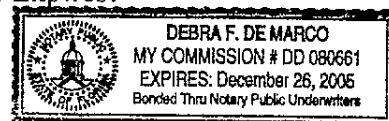


