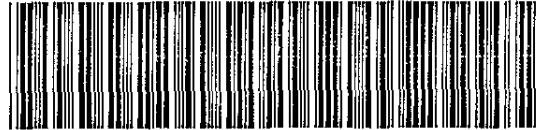

ARTICLE VII – PURPOSE

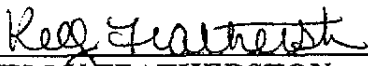
**The purpose for which the corporation is organized is to engage in
