ARTICLE I - NAME

The name of the corporation shall be REL Alternative Solutions Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

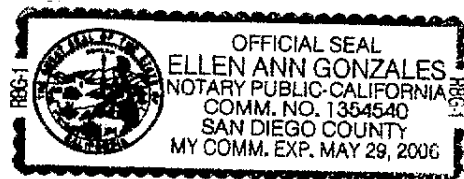
