ARTICLES OF INCORPORATION  
OF

ARTICLE I. NAME

The name of this corporation is  
BROTHERS LEAK DETECTION INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of  
transacting any or all lawful business.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of



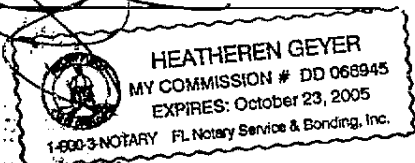


