**The name of the corporation is FINAL CUT CLEANING COMPANY**

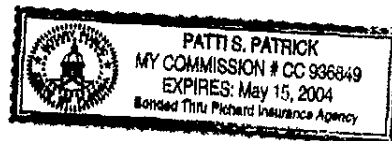
