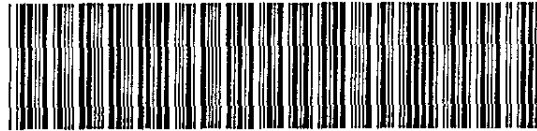



NAME

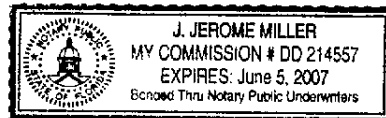
