## ARTICLES OF INCORPORATION OF Spolar Enterprises, Inc.

*The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

### ARTICLE I - NAME


