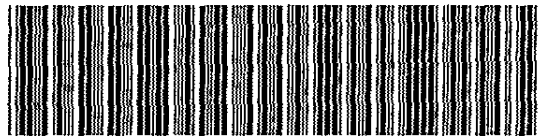



ARTICLE I. NAME

This corporation shall have perpetual existence, commencing on the 10th


