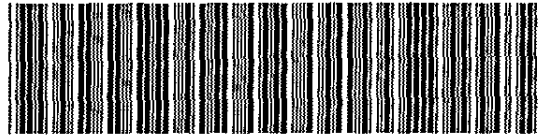

**ARTICLES OF INCORPORATION  
OF

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the state of Florida.

**ARTICLE I- NAME**

The name of this corporation is Lopez Pressure Cleaning West Fort Myers, Inc.

**ARTICLE II- DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

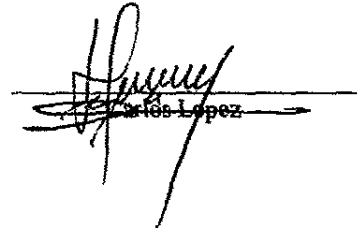
**ARTICLE X- INDEMNIFICATION**

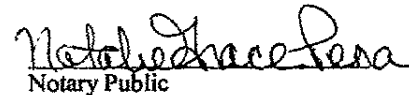

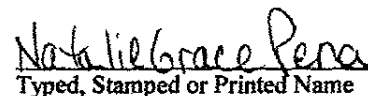

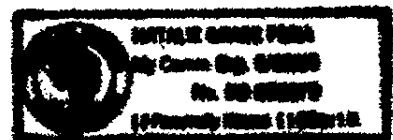
