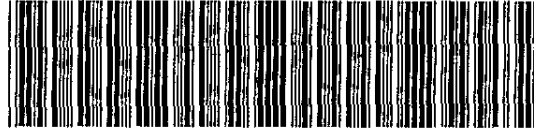

**ARTICLE I  
NAME**

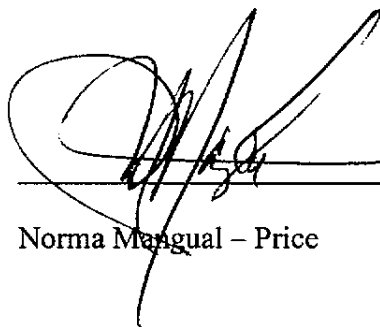
**ARTICLE IX**

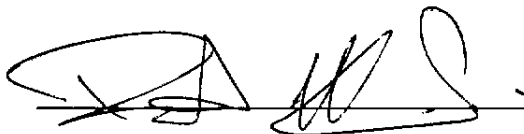

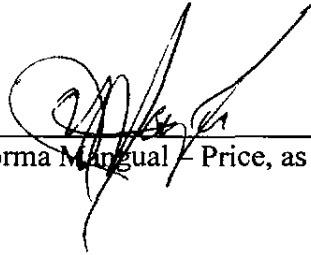

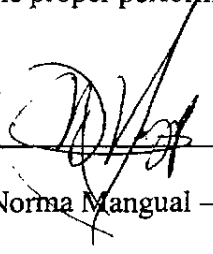
