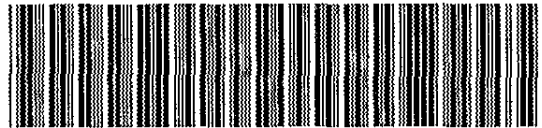

The name of this Corporation is LEASA MANUFACTURING CORPORATION.
