**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

These Articles of Incorporation may be altered or amended by a resolution adopted by the Board of Directors and presented to and approved at a meeting of shareholders by the holders of the majority of

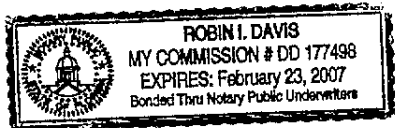
the shares entitled to vote thereon, or they may be altered or amended in any other manner now or hereafter provided by law.
