ARTICLES OF INCORPORATION

OF

PRINCESS PRODUCTIONS, INC.

<u>ARTICLE I</u>

Name and Duration

The name of the corporation is Princess Productions, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 11801 Bramble Cove Dr., Fort Myers, Florida 33905.

ARTICLE III

Registered Office and Agent
