ARTICLES OF INCORPORATION OF ARX INSURANCE SERVICES, INC.

Article I

Name. The name of this Corporation is ARX INSURANCE SERVICES, INC.

Article II

Principal Office. The principal place of business and mailing address of this corporation shall be: 7201 N.W. 11th Place, Gainesville, Florida 32605.

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.
