**ARTICLES OF INCORPORATION
FOR

A FLORIDA CORPORATION**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation ("Corporation"):

TOMMY TOUCAN'S, INC.

ARTICLE II – PRINCIPLE OFFICE

The street address of the principal office of the Corporation is 751 S. Pinellas Avenue, Tarpon Springs, FL 34689.

ARTICLE III – SHARES & SHAREHOLDERS

The maximum number of shares this Corporation is authorized to issue is ten-thousand (10,000), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

The Corporation will at no time have more than seventy-five (75) eligible shareholders as defined in IRC §1361(b)(1)(A), (B), (C), & IRC §6013(g).

ARTICLE IV – RESTRICTION ON SALE OF SHARES

All offers for sale of shares in Corporation shall be private offerings. No offer for sale of shares of Corporation will be made outside the State of Florida or to offerees residing outside the State of Florida. Also advertisement and general solicitation for sale of shares in Corporation is prohibited.

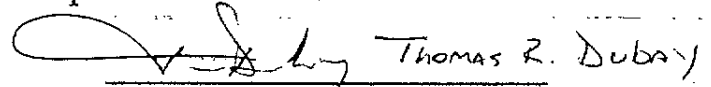
